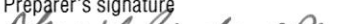

THE SOUTHSIDE DROP-IN CENTER OFFERS A RANGE OF SERVICES (IN ENGLISH AND SPANISH AND WITH ACCESS TO A LANGUAGE LINE FOR ADDITIONAL SUPPORT) DESIGNED TO HELP PEOPLE STABILIZE THEIR LIVES. IT STARTS WITH A MEAL AND OTHER STREET-LEVEL HUMAN SERVICES, INCLUDING SHOWERS, LAUNDRY SERVICES, MAILING ADDRESS, AND MONTHLY ACCESS TO OUR FOOD PANTRY, AND CONTINUES WITH HOUSING ASSISTANCE, JOB SEARCH SUPPORT AND TOOLS, AND CASE MANAGEMENT. IN 2022, THE SOUTHSIDE DROP-IN CENTER SERVED OVER 22,000 HOT, NUTRITIOUS MEALS AND PROVIDED STREET-LEVEL HUMAN SERVICES TO NEARLY 1,500 PEOPLE, INCLUDING SHOWERS AND ACCESS TO LAUNDRY AND MAILING SERVICES, BILL PAYMENT, EMERGENCY SUPPLIES, HEALTH CLINICS, AND CASE MANAGEMENT.
